When Completing This Application, Provide:

1. **Alaska Residence Address Where You Live** – A complete physical residence address **must** be included on your application. The residence address you provide will be used to assign your voter record to a voting district and precinct. Your application will not be processed if you leave the residence address blank or if you provide a PO Box, HC No. and Box, PSC Box, Rural Route No., Commercial Address or Mail Stop Address in section 4 of the application.

If your residence has been assigned a street number, provide that number. If not, indicate exactly where you live such as, highway name and milepost number, boat harbor with pier and slip number, subdivision name with lot and block or trailer park name and space number. If you live in a rural village in Alaska, you may provide the community name as your residence address.

Are you temporarily out of State? If so, and you have intent to return, you may maintain your Alaska residence as it appears on your current record. If you provide a new residence address, it must be within Alaska.

2. **Proof of Identity** – Your identity **must** be verified. If you have been issued a Social Security Number, an Alaska Driver's License or an Alaska State ID card, you **MUST** provide at least one number in section 6 of the application. If you have never been issued one of the identification numbers, you may indicate so by checking the box in section 6.
3. **Date of Birth**
4. **Are you submitting this application by mail or by fax?** If so, and if you are not already registered to vote in Alaska, your identity **must** be verified. If you have not been issued one of the identification numbers listed in section 6 of the application, your identity may be verified by submitting a copy of one of the following documents:

- Current and valid photo identification
- Passport
- Birth certificate
- Driver's license
- State identification card
- Hunting and Fishing license

If you do not provide proof of identification at the time of registration, you will be required to meet certain identification requirements at the time you vote.

5. **Are you registering from outside the State of Alaska?** If so, you **must** provide proof of Alaska residency, such as a copy of your current Alaska driver's license, hunting or fishing license, student loan documents, proof of employment in Alaska, or military leave and earnings statement.
6. **Have you been convicted of a felony?** If so, you may register to vote only if you have been unconditionally discharged. Provide a copy of your discharge papers with this application if available.
7. **Party Affiliation** – Those parties that have gained recognized political party status under Alaska Statutes 15.60.010(23) or by court order are listed under **Political Parties**. Those groups that have applied for party status but have not met the qualifications to be a recognized political party under Alaska Statutes 15.60.010(23) are listed under **Political Groups**. Under **Other**, nonpartisan means you are not affiliated with any recognized political party or group and undeclared means you do not wish to declare a political affiliation. If you do not check a political affiliation, you will be registered as undeclared unless you are already registered under an affiliation.
8. **Primary Election Information** – Your party affiliation 30 days before the election will determine the ballot selection you are eligible to make. You **must** select a ballot type that is available to you and corresponding to your party affiliation in section 13. If you are not affiliated with a political party or group and you do not select a ballot type, your application will be returned to you.

Combined Party Ballot & Ballot Measures – will have recognized political party candidates from the Alaska Democratic Party, Alaskan Independence Party, Green Party of Alaska and ballot measures – any voter may select this ballot.

Republican Party Ballot – will have recognized political party candidates only from the Alaska Republican Party and ballot measures – **ONLY** voters registered as Republican, undeclared or nonpartisan may select this ballot.

Ballot Measures Ballot – this ballot will have only ballot measures and no candidates will appear on this ballot.

9. **Are you overseas or in a remote area of Alaska?** – If so, check the box on line 15 to request a special advance ballot. This ballot is a blank ballot with spaces for you to write-in the names of the candidates you wish to vote for. This ballot is intended for those who are overseas or in remote areas of Alaska where the mail service may be slow. You will also be mailed the official ballot 2-3 weeks before the election. You may vote and return both ballots. If both ballots are returned, we will count only the official ballot.
